MONTHLY REPORT ON ACTIVITIES OF NETFISH DURING AUGUST 2020

Field level training programmes could not be executed in any of the coastal states during August 2020, due to Covid-19 situation in the country. However, a few meetings/discussions by direct as well as virtual means were carried out, as an initiation to start the field level trainings. The activities performed by NETFISH during the month are briefed below.

- ➤ Convened the 29th Executive Committee meeting on 20th August 2020 through VC.
- ➤ Collected the details of various companies/organizations in each state, which can provide CSR fund to NETFISH for executing its activities.
- Organized virtual meetings with fisheries officials and stakeholders regarding formation of clusters in fishing harbours, fishing vessel clusters, formation of FPOs, FIPs, status of fishing activities in each region, joint programmes with other organizations, methods to reduce post harvest loss, implementation of square mesh cod ends, development of dry fish activities, etc.
- ➤ Conducted stakeholders meeting with Matsyafed Officials at Vaikom regarding implementation of SC/ST fishermen and fisherwomen livelihood improvement project at Kottayam district.
- ➤ Disseminated various information and awareness messages on post-harvest loss, conservation, sustainable fishing, Govt. schemes etc. through Whatsapp to boat owners, stakeholders association and fishermen etc. in the respective fishing harbour and fish landing centre.
- ➤ Had virtual meeting by CE NETFISH with all the SCOs regarding initiation of training programmes, cluster formation, development of FPOs, NETFISH-CIFNET joint programmes, Fishery improvement programmes, External fund generation, Dry fish/PPC surveys, Marine Mammal project, etc.
- ➤ Conducted surveys over phone and through HDCs about Dry fish units/activities and unauthorized Pre-processing centres in each state and prepared the survey reports.
- ➤ Collected the details of certified skippers in each state for conducting NETFISH-CIFNET joint programme.
- > Prepared the draft of the training manual for Processing workers and Supervisors.

Gujarat	Due to continuous meetings by NETFISH with Office of Commissioner of fisheries and Secretary Fisheries for implementation of state specific action plan, the Commissioner of Fisheries, Gujarat has issued a Circular regulating fishery along the state. The circular restrict bottom trawling within 5 nm from shore, usage of trawl net without cod end less than 40 mm etc.
West Bengal	Hygienic handling practices have improved at various fishing harbours. Freserganj harbour- Polythene sheets are now used for sorting of fish and cleaned crates are used for fish storage and transportation. Kakdwip harbour - plastic crates are used for keeping fishes. Sankarpur harbour- Fishes and shrimps are preserved with adequate ice in net baskets and are covered with poly sheet.
