In order to create awareness among the sea going fishers specially the skippers of the mechanized fishing vessel on safety measures at sea, a three days training programme cum workshop was organized by NETFISH-MPEDA, Kolkata in collaboration with the Institutions of Engineers (India)- Rural Development Forum, supported by Bose Institute, Kolkata at Freserganj Panchayat Office, South 24 Parganas from 2nd to 4th February 2020. About 50 participants including boat skippers, engine drivers and crew members were actively participated in the programme. The programme was inaugurated by Shri. S. K. Banerjee, Ex-President, IE-RDF. Shri. Abhijit Dasgupta, Commandant, Indian Coast Guard, Freserganj station was the chief guest of the programme and he talked about various types of hazard faced by the fishermen while on fishing, and precaution to be taken to avoid such incidents and rules of the road for safe navigation. Shri. Atanu Ray, State Coordinator briefed about the three days programme and also expressed that all the fishing vessels should be well equipped with various life saving equipments such as life jackets, life buoy, DAT, GPS and other navigational equipments. Shri. Jayanta Pradhan, Asst. Director of Fisheries (Marine), Diamond Harbour highlighted on MFR Acts of West Bengal. The resource persons explained in details about various aspects of sea safety, navigation, seamanship, diesel engine and its maintenance through power point presentation. A practical demonstration on use of life jacket, life buoy, DAT and GPS

were also shown to the trainees. A training kit and certificate was also distributed to all the participants.

Two numbers of NFDB Sponsored Onboard training programme for "Popularization of Square mesh cod ends in Trawls" were conducted on 14<sup>th</sup> and 25<sup>th</sup> February 2020 at Deshapran fishing harbour and Rasulpur landing centre, Purba Medinipur. A total of 30 participants attended the training programme. Onboard trials were conducted using 20 mm and 15 mm Square mesh cod end covered with diamond mesh cod end. The trainees observed the positive result with 20 mm square mesh cod end and they expressed their willingness to operate square mesh cod end instead of diamond mesh cod end to sustain the marine resource. NETFISH distributed training kit and certificate to the participants.

As part of Joint capacity building programmes for SC fishers under the SCSP component of the ICAR-CIFT, 28 training programmes including 6 onboard training programmes, 6 Fishing harbour/landing centre/ fishermen village training programme, 14 dry fish training programmes and 2 Skill development training programme on Value added fishery product were conducted in February 2020. Hygienic handling of fishes onboard and conservation measures onboard were taught to the 47 trainees attend the onboard training programmes. Around 180 beneficiaries attended the fish quality management training programme in the fishing harbour and landing centre. The dry fish trainings included hands on training on hygienic production of dryfish and 420 nos. of SC fisherwomen were benefitted by these trainings. To improve the livelihood of SC fisherwomen community, 2 hands on training programme on 'Value Added Fishery Products' were conducted at Amarabati, Freserganj and Jharkhali, South 24 Parganas. A total of 40 SC fisherwomen attended the training and they were given hands on training on preparation of products such as Fish Ball, Fish Pickle, Prawn Pickle, Coated Prawn products such as Breaded Butterfly, Breaded Stretched Shrimp, Fish Pakora, Fish cutlet, Fish fry etc. from low valued fishes.

"One week Skill Development training programme for SC fishers" under SCSP programme of CIFT was conducted at Jayantipur, Chilka from 12<sup>th</sup> to 17<sup>th</sup> February 2020. The six days long programme started with an inaugural function followed by technical sessions on various topics

related to fisheries and exposure visit to seafood plant, landing centre and aquaculture farm. Officials from MPEDA, State Fisheries Department, members of Chilka Development Authority, members of Jayantipur PFCS, SCO, NGO and 30 fishermen were attended the inaugural function. It was followed by technical sessions on capture fisheries and culture fisheries in Chilka Lake, Export variety fishes in Chilka Lake, HACCP, etc. On the second day discussions were conducted on Odisha Marine Fishing Regulation Act (OMFRA), Potential Fishing Zone, subsidy schemes applicable to Chilka area and FFMA (Fisher Friendly Mobile App) which gives climate related information. On third day, the trainees were taken to M/s.Magnum Seafood pvt. Ltd to study and understand different steps in processing unit ie., from raw material receiving, pre-processing, processing (block & IQF), packing and cold storage. On the fourth day, another field visit was arranged to aquaculture farm where the trainees got the opportunity to visit the crab bank and observed several stages of handling methods in the crab bank with optimum hygiene from the collection of mother crab till the release of crab lings to the sea. Feedback of the training programme was discussed on the next day and a plastic waste collection programme was conducted to keep the fishing jetty and surrounding village area plastic free. A boat cleanup programme was also organized on the final day at Chilka fish landing centre. Evaluation of the training programme was also conducted on the last day and certificates were distributed to all the participants.

The second programme in this context was conducted at Sanapatana Village, Puri from 24<sup>th</sup> to 29<sup>th</sup> February 2020. The second programme also included technical session on various topics related to fisheries and exposure visit to Seafood processing unit, Aquafarm and landing centre.

On 20th of the month, NETFISH had organized a Skill development training programme on production of Sashimi grade tuna to the fishermen at Pudimadaka fish landing center. Around 30 hook and line fishermen attended the programme in which State coordinator, NETFISH demonstrated the various steps in processing of Sashimi grade tuna, like spiking, bleeding, gilling, degutting, chilling, icing and storage.



NETFISH had conducted two numbers of Sea Safety & Navigation training programmes at Pudimadaka fish landing centre and Visakhapattinam fishing harbour on 25<sup>th</sup> and 28<sup>th</sup> of the month respectively. Dr. Phani Prakash, Joint Director, Dr. Lakshmana Rao, Assistant Director and FDO's from Department of Fisheries, Sri. Prasad Naik, AD, SRD, MPEDA Vizag, Circle

Inspector, Superintendent Inspector and Guards from Marine Police Station, Presidents from Fishermen Associations & Fishermen Societies and around 102 active fishermen were participated in these programmes. Shri. Prasad Naik, AD, MPEDA explained the MPEDA subsidy scheme for By-Catch Reduction Devices, Turtle Excluder Devise and Vessel Monitoring System. Marine Police demonstrated the use of lifesaving equipment such as life buoy, Life jacket etc. to the participants. Shri. Murthy, Representative from M/s Elekrtonic Lab (I) Pvt Ltd., Visakhapattinam demonstrated the Inmarsat Satellite ISAT2 phone to the boat owners and Dept of fishery officials. The Department officials explained the significance of Distress alert button available in the ISAT phone and also suggested the boat owners to keep adequate number of lifesaving equipments in their fishing boats.

NFDB sponsored onboard programme for popularization of square mesh cod end was conducted at Machilipattinam fishing harbor on 27th February 2020. Shri.Lanke Venkateswara Rao, President, Machilipatnam Mechanized Boat owners Association inaugurated the function. During the inaugural function, State co-ordinator, NETFISH explained the importance and advantages of square mesh cod end to the trainees. The onboard trial was conducted with 2 cod ends ie., 20 mm diamond shaped cod end and 25 mm square mesh cod end. Both these cod ends were covered with a layer of 10 mm sized net to collect the by-catch. After the onboard trial fishermen noticed that due to the less by-catch in 25 mm square mesh cod end segregation of catch was so fast and also noticed that about 2 litres diesel per hour was saved while using 25 mm square mesh cod ends when compared with the 20 mm diamond cod ends. After the onboard trial, the trainees were convinced the advantages of square mesh cod end. A total of 30 fishermen attended the training programme. NETFISH distributed training kit including notebook, pen and training manual and T-shirt, gum boots and hand gloves to the participants.

One of the Tuna fishing boat owner from Kakinada fishing harbour paid the full amount and booked the INMERSAT ISAT2 Phone and received the handset with the



registration and license from BSNL and WPC. The application process was done by M/s. Electronic labs, Visakhapatam. The set was handed over to him by Shri. Mopidevi Venkata Ramana, Minister of AP State Fisheries on 26<sup>th</sup> February 2020 at the Commissioner Office in a meeting of APFCOF. Shri. Vijayakumar Yaragal, JD MPEDA and Shri. Brahmeswara Rao AD RD MPEDA Vijayawada arranged the platform and made the programme success.

During the month 2 nos. of awareness programmes on Sea Safety Navigation and was conducted in Thoppumpady fishing harbour. The programmes included awareness class navigational signals, rules of the importance of license, lifesaving equipment, etc. Practical



demonstration of use of life jacket was also done during the programme. A total of 60 beneficiaries had attended the training programmes.

A mass communication programme was conducted at Thoppumapdy fishing harbour on 11<sup>th</sup> February 2020. Around 45 fishermen were benefitted through the programme in which awareness notices about hygienic handling of fish and ice at fishing harbor were distributed among them.



To improve the hygienic condition in fishing harbour, landing centre and processing centers, various stakeholders meetings were organized during the month in Kerala South region. A stakeholder meeting was organized at Chamber of Kerala Seafood Industry, Eramallur on 11<sup>th</sup> February 2020. Around 60 peeling shed owners were attended the meeting in which hygienic improvement in peeling shed, License renewal & online registration of peeling shed were discussed in detail. Smt.Preetha, Technical Officer, RD MPEDA, Vallarpadam also attended the meeting and explained the procedures for license renewal and online registration.

On 18th of the month, NETFISH and Harbour Engineering Department had jointly organized a stakeholder meeting at Sakthikulangara fishing harbour. SCO NETFISH, Executive Engineer, Assistant Executive Engineer and Assistant Engineers from Sakthikulangara & Neendakara Harbour Engineering Division, Health Inspector, Assistant Director of Fisheries Neendakara, Boat owners and union representatives were attended the meeting. During the meeting, points like hygiene condition of the harbour, fish selling inside auction hall, empty box inside the auction hall at Needakara harbour, improper washing, dredging, hand washing facility, need of replacement of the present roofing at the Neendakara auction hall, need of CCTV camera, repacking of outside fishes in the harbour, unhygienic handling of export variety fishes in the open floor were discussed. The boat owners asked for proper dredging at the harbour. Executive Engineer assured that dredging will start within 15 days. She also agreed to provide jet washing facility for washing the auction hall within two months and also agreed to extend the auction hall length at Sakthikulangara fishing harbour. For the security issues HED will set

up one CCTV camera at Sakthikulangara and Depatment of fisheries will set up one CCTV camera at Neendakara fishing harbour.

Another stakeholder meeting was conducted at Azheekkal fishing harbour on 19th of the month in which discussion was conducted regarding the issue of dumping plastic waste inside the fishing harbour.

To eradicate child labour and child trafficking NETFISH in association with Anti human trafficking unit, Kochi had organized an awareness programme "Bachpan Bachavo Andolan" at Thoppumpady Fisheries Harbour on 24th February 2020. The programme was mainly targeted to the boat owners, boat workers, and labor suppliers to the Sea food Factories. Smt. Sangeetha N.R, SCO NETFISH welcomed the gathering. Smt. Betty mol, Sub Inspector of Police, Anti Human Trafficking Unit, Kochi inaugurated the programme. During her inaugural address she highlighted about child labor, sexual abuse, human trafficking and its punishment. Very good discussion was carried out regarding these issues and she gave control room phone numbers to the stakeholders for passing the messages regarding the issue. SCO gave detailed class on fishing zones, documents required while going for fishing, sea safety & navigation, fishing boundaries etc. Shri. Vinod Khanna, ASI, Coastal Police explained their activities and experiences. Shri. S. Ramakishnan, Secretary, SEAI explained the activities in the Seafood companies and criteria for selecting labors. He mentioned that present criteria for selection of workers and their age identification are not sufficient and more checking system is needed in future. Around 90 participants attended the awareness programme.

NETFISH conducted a door to door awareness programme at Pallippuram village in Munambam

area on 12th February 2020. The aim of the programme was to spread the message of NETFISH regarding sustainable fishing to fishermen. SCO along with Shri. Unnikrishnan A.V., local coordinator had visited around 25 houses in the area. Fishermen freely and openly discussed the various ill doings in the fishing sector such as night fishing, use of very big nets and engines in



the sector. NETFISH message were conveyed and valuable information from the ground level was also collected back from the fishermen. NETFISH distributed bathing soap to fishermen as a token of appreciation.

NFDB sponsored onboard programme for popularization of Square mesh cod end in trawl net was conducted at Munakkakadavu fishing harbor on 19th February 2020. A shrimp trawl from Munakkakadavu harbour was used for the onboard trial. During the programme, SCO delivered a lecture



on importance and advantages of square mesh cod end to the trainees. Mr.Unnikrishnan. A.V, a trained trainer was the resource person of the training programme and explained the technical aspects of square mesh cod end and showed how the cod end should be connected to the main trawl net. Then the trainer and a trainee together attached the square mesh cod end to the main trawl net. After this, trawl net with square mesh cod end was released to the sea. After one hour hauling, the onboard trial was finished with a good catch of shrimp, crab and squid. The catch was very clean, free of mud and negligible amount of juvenile fishes. Thus the sorting operation was found simple. The eye appeal of the catch was also impressive. A marine turtle was also caught in the trawl net as there was no turtle excluding device (TED) attached. The turtle was safely released back to the sea. After the onboard trial, the trainees were convinced that there is

no any considerable loss of caught fish varieties due to the use of square mesh cod end. The trainees requested to conduct similar programmes in more fishing boats in order to spread the matter quickly. A total of 15 fishermen attended the training programme. NETFISH distributed certificates to all the participants.

To create awareness among the sea going fishermen regarding the necessity of life saving equipments in fishing boats, NETFISH had conducted an awareness programme on 25th February 2020 at Munambam harbour. The NETFISH State



Co-ordinator took class on KMFRA amendments, new rules, basic life saving equipments, navigation equipments, navigation signals etc. and demonstrated use of life jacket to fishermen. Around 34 numbers of skippers (srank) of trawl boat attended the awareness programme. All of them are not having a valid srank licence although they are having many years of experience as skipper in fishing boats. SCO sensitized them about the need of taking srank license. All the participants expressed their willingness to take srank licence. SCO further contacted the Port officer at Kodungallur in charge of issuing srank licence and explained the matter. A link has been created so that all the 34 sranks can approach the port office at Kodungallur to get the license after going through the official procedures. The awareness programme was much helpful to the fishermen and they appreciated NETFISH for conducting the programme.

Another 2 Sea Safety & KMFRA awareness programme was jointly organized by NETFISH and Department of fisheries, Kerala at Munakkakadavu and Chettuva on 14<sup>th</sup> and 20<sup>th</sup> of the month respectively. During the programme, SCO NETFISH took classes on topics KMFRA amendments, new rules, basic life saving equipments, navigation equipments, navigation signals etc. Around 65 fishermen attended the awareness programme.
